<u>Reservation</u>: As per GOI norms. However, being a temporary and contractual mode position, if such suitable candidate is not available, the same will be treated as unreserved.

<u>Tenure</u>: The post is purely temporary basis. The assignment is initially for a period of one year, which may be curtailed/extended depending on performance of candidate and requirement.

N.B:-

- 1. The date of Walk-In-Interview is on 22<sup>nd</sup> June 2015 and is the cut –off date for all the purpose.
- 2. Director, NCAOR has the right to relax the eligibility criteria of the candidates of exceptional track record and experience matching to the requirement and also to cancel the requirement process at any stage, without assigning any reason thereof.
- 3. The person engaged will not be treated on par with regular employees of NCAOR and shall have no right to claim implicit or explicit for their absorption or regularization in NCAOR.
