1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 2. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. 3. 1. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

(i) All the items are required for the Indian Antarctic Stations. In order to ensure the quality & environment friendly material, the items must be of established brands known for their commitment to environmental sustainability, in accordance with Antarctic Law and environment protocol.

(ii) Bidders to provide compliance on all Technical Specifications in the format attached in Buyer Added Bid Specific ATC along with the Product Catalogue/Photo of the product(s) offered in the bid. Buyers can match and verify the Product Catalogue/photo with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

(iii) Any requests for extension of the bid submission deadline may not be considered, as timely procurement is essential to ensure receipt of the materials within the required schedule.

(iv) To ensure transparency, quality assurance, and compliance with procurement standards, all items quoted in the tender must have clear and specific product information, including the product name and brand offered against each item.

- (v) Each item should be quoted with a single, established market brand. Bidders quoting items with multiple brand options or vague descriptors such as "good brand," "quality," "normal," "reputed," "branded," "local," or "unknown brands" may render the bid non-compliant and subject to rejection.
- (vi) Returns and Replacements: The return & replacement shall be completed by the bidder/supplier at their own expense. Self-declaration should be submitted for compliance of the term.
- (vii) In case if any counterfeit, substandard, defective item is supplied or any manipulation is observed, then the items will be rejected, EMD will be forfeited & the supplier will be blacklisted by the organization.
- (viii) Rates quoted should be inclusive of packing, transportation, labour toll, & any other charges. The supplier has to intimate the buyer in writing the delivery date in advance (within the contract period) and make all arrangements of loading/unloading by his own.
- (ix) Bidders are required to submit a completed Bidder Registration form signed & sealed as per the attached form in point 4 in the technical bid for the vendor registration process.
- (x) GeM is capturing and showing the IP addresses used by the buyer and the seller(s) in this bid. Accordingly, the sellers' IP addresses will be verified, and any bidder/seller sharing a common IP address will be rejected outright.
- (xi) On award of the contract, if the material is found not complying with given specifications or low standards will be rejected & an incident will be raised in GeM.

Tender Evaluation Eligibility Criteria:

- 1) As this tender comprise a wide range of items across multiple brands, it is not feasible for a single manufacturer to produce all the required items. Accordingly, all the participating bidders/suppliers shall be treated as Traders and not Manufacturers for the purpose of this tender. Consequently, no bidder/supplier shall be eligible to claim EMD/Bid Security exemption or Purchase Preference benefits under the MSME policy.
- 2) As stipulated in the eligibility criteria, all the supporting documents are to be submitted as part of the Technical Bid, failing which the bid may be liable for rejection.
- 3) As stipulated in the Buyer ATC, all the documents listed below shall be duly completed, signed, and affixed with the bidder's/supplier's seal on the official letterhead. Submission of these documents as part of the Technical Bid is mandatory, failing which the bid may be liable for rejection.
