1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- (ix) Book Examination Clause: The Procuring Entity reserves the right for 'Book Examination' as follows: T

he Bidder/contractor shall, whenever called upon and required to produce or cause to be produced, for exa mination by any Government Officer duly authorised in that behalf, any cost or other book of account, vou cher, receipt, letter, memorandum, paper or writing or any copy of or extract from any such document. Th e Contractor shall also furnish information relating to the execution of this contract or relevant for verifyin g or ascertaining the cost of executing this contract to such Government Officer in such manner as may b e required. The decision of such Government Officer on the question of relevancy of any document, inform ation of return being final and binding on the parties. The obligation imposed by this clause is without prej udice to the contractor's obligations under any other statute, rules or orders which shall be concurrently bi nding on the contractor. The contractor shall, if the authorised Government Officer so requires (whether be fore or after the prices have been finally fixed), afford facilities to the Government Officer concerned to visit the contractor's premises to examine the processes of production and estimate or ascertain the cost o f performance of Contract. The authorised Government Officer shall have power, muted is mutandis, to ex amine all the relevant books of Contractor's subcontractor, or any subsidiary or allied firm or company, if a ny portion of the contract is entrusted or carried out by such entities.
