- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

- VI. The Bidders to provide basic details sought in Buyer Added Specific ATC.

- VII. The amount of Agency Commission (not exceeding the prescribed limit) payable to the Indian Agent shoul d not be more than what is specified in the Agency agreement (a certified copy should be submitted along with the bid) between the bidder and the Indian Agent. The Indian Agent will be required to submit a certificate along with their Agency Commission bill, confirming that the amount claimed as Agency Commission in the bill has been spent/will be spent strictly to render services to the foreign Principal, in terms of the Agency Agreement. The Purchaser or their authorized agencies and/or any other authority of the Government of India shall have rights to examine the books of the Indian Agent, and defectsor misrepresentations in respect of the afore-indicated confirmation coming to light during such examinations will make the foreign Principal (i.e. the Contractor) and their Indian Agent liable to be banned/suspended from having business dealings with the Purchaser, following laid down procedures for such banning/suspension of business dealings.
- VIII. **Undue profiteering:** Bidder shall specifically mention this fact in his bid giving reasons for quoting a hig her price(s). If he fails to do so or makes any misstatement, it shall be lawful for the Procuring Entity either to revise the price at any stage to bring it in conformity with the OEM prices or to terminate the contract a nd avail all the remedies available therein in addition to other punitive actions for violation of Code of Inte grity.
- IX. Book Examination Clause: The Procuring Entity reserves the right for 'Book Examination' as follows: Th e Bidder/contractor shall, whenever called upon and required to produce or cause to be produced, for exa mination by any Government Officer duly authorised in that behalf, any cost or other book of account, vou cher, receipt, letter, memorandum, paper or writing or any copy of or extract from any such document. Th e Contractor shall also furnish information relating to the execution of this contract or relevant for verifyin g or ascertaining the cost of executing this contract to such Government Officer in such manner as may b e required. The decision of such Government Officer on the question of relevancy of any document, inform ation of return being final and binding on the parties. The obligation imposed by this clause is without prej udice to the contractor's obligations under any other statute, rules or orders which shall be concurrently bi nding on the contractor. The contract or shall, if the authorised Government Officer so requires (whether b efore or after the prices have been finally fixed), afford facilities to the Government Officer concerned to vi sit the contractor's premises to examine the processes of production and estimate or ascertain the cost of performance of Contract. The authorised Government Officer shall have power, muted is mutandis, to exa mine all the relevant books of Contractor's subcontractor, or any subsidiary or allied firm or company, if an y portion of the contract is entrusted or carried out by such entities. If on such examination, it is establishe d that the contracted price is more than the actual cost-plus reasonable margin of profit, the Procuring Enti ty shall have the right to reduce the price and determine the amount to a reasonable level. The Contract or or its agency is bound to allow examination of its books within 60 days from the date the notice is received by the contractor or its agencies calling for the production of documents. In the event of the contractor's or his agency's failure to do so, the contract price would be reduced and determined according to the best ju dgment of the Procuring Entity, which would be final and binding on the contractor and his agencies.

9. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

10. Warranty

Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.

11. Warranty

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 3 days time limit. In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
